Summary Sheet

Proposed Federally-Assisted Housing Development for

North Bennington

- A. <u>Proposal</u>: 40 units of apartments for the elderly and handicapped on campus land (nearby Night Pastures) just north of the Faculty Houses
- B. <u>Developer</u>: Pamela Gleichman will build, own and operate the development
- C. Extent of <u>Contribution</u>: The College will contribute land to Ms. <u>Gleichman who in turn and as a separate</u> event, will contribute to the College out of the syndication proceeds of the development
- D. Apartment <u>Plans</u>: There will be 30 1-bedroom and 10 2-bedroom apartments. Four apartments will be designed for handicapped persons. The apartments will be clustered in five 2-story buildings. There will be a community building and spaces for 32 cars. The development will be separated from the campus and retain the existing meadows and pine trees which define the site.
- E. Nature of Federal <u>Assistance</u>: This development will proceed only if subsidies are made available through the Farmers Home Administration which is a branch of the United States Department of Agriculture. The subsidy will reduce the interest for the mortgage which Ms. Gleichman will need to raise the capital for the development. In addition, Farmers Home makes available rental assistance subsidies known as Section 8 to needy tenants.
- F. History of Development
 - April, 1981: Ms. Gleichman indicated to Joe Murphy interest in development of site
 - May-July, 1981: Ms. Gleichman met with President Murphy and Development Committee of Board of Trustees. Presented architect's plans. Board of Trustees approved resolution authorizing College to proceed with development
 - July 31, 1981: Ms. Gleichman submitted applications for federal assistance to Vermont office of U.S. Farmers Home Administration (FmHA)

- 4. October 19, 1981: After 2 months of discussions Vermont FmHA office rejected application for following reasons:
 - ° site is remote from basic services for elderly
 - ° College is undependable alternate source of services
 - of prospective tenants may be too low for public assistance (?)
 - management budget is lower than FmHA experience
 - project costs are too high
 - o no need for additional elderly housing
- 5. November 6, 1981: Ms. Gleichman's attorney requested an appeal from the Vermont State office decision. Meeting will be arranged in Washington to present appeal to U.S. Department of Agriculture officials. Basis for appeal is as follows:
 - o site is ideal for elderly housing
 - Ms. Gleichman's track record as manager in these programs is so outstanding that it supports her operating budget estimates even if they are lower than those the government uses for its estimates
 - demand for affordable housing is extremely high in all income brackets
 - costs are reasonable
- G. <u>Present Analysis and Agenda</u>: The present Administration would rather not fund any developments. These rejections are more or less routine. An appeal must do the following in order to succeed:

1. Indicate to high government officials that this is in fact an outstanding proposal and

2. Indicate that there is so much support for the project that politically it is impossible to reject without reason. In short, federal assistance is going to those who "shout the loudest".
