My dear President Leigh,

At the meetings of the Allied Social Science Associations at Christmas, a group of American social scientists met to consider the placement of exiled foreign scholars. It was agreed upon that a list of refugee scholars in the social sciences should be compiled and circulated. With the help of members of the Graduate Faculty of the New School for Social Research in New York, and of the "Notgemeinschaft Deutscher Wissenschaftler im Ausland," a list of almost 100 persons has been compiled, a copy of which I am taking the liberty of enclosing.

May I ask you to examine the list for persons who might fit into your department or other departments in your institution, or in others known to you. It is very urgent to find positions for these men and women for the coming academic year. Not all of them need to be given a teaching post. For many of them, especially the younger ones who are unmarried, or who are married but childless, an assistantship or a fellowship would be extremely welcome, since it would give them a chance to acclimatize themselves in an American academic atmosphere. Practically all of them are familiar with English, and some speak it fluently. Several have spent long periods in the United States prior to their exile from their native countries. Of those who are qualified for teaching positions, several are teachers of international reputation, and all have had a certain amount of teaching experience. With regard to their scholarly attainments, a number of the men stand at the very top of their respective professions, and virtually every one--even the youngest--has some very estimable publications to his credit.

In smaller institutions, most of the candidates could teach foreign languages, especially German and Italian, in addition to the social sciences. As regards nationality, the list includes Germans, Austrians, Czechoslovakians, Italians, and one Pole; and as regards religion, Protestants, Catholics and Jews.

I am sure you will agree with me on the urgency of helping these victims of political, religious and racial persecution, to locate positions as teachers, research and teaching assistants or fellows. It is not merely a question of relief of suffering, though this is a real obligation upon us as their professional colleagues. It is a question of securing for America and diffusing throughout the country the very substantial contributions they can make to research and to education. If you see any possibility of placing them, at your own institution or elsewhere, I urge you to write at once, either to the man in question or, if further data are wanted, to me or to the colleagues indicated as references.
