When they returned to the College, one of the boys got out of the car and aimed the gun at the Franklin House light. Betty Haas stopped him. They went to Franklin and then three shots were heard. After they all got into the house, Kip Humphreys and Nancy Dennis went to their rooms and changed their clothes. With five guns, they decided to go out and have a Wolff hunt. Then more shooting was he rd. For five minutes they ran around the circle yelling about the Wolff hunt and shooting. Edith Stevens called the policeman who came much later. When the policeman came, they were all on the floor and were quiet. Nanette Smith was the only one who seemed to have any sense. She was trying to help. Alice Levitt was in the card room with two boys and heard the whole incident.

In November Edith Stevens said, these same Dartmouth boys came and upset Nancy Dennis's room and Kpp Humphreys' room.

It was also stated that March 18, 1941, Nancy Dennis and Kip Humphreys used the toilet seats of Franklin House as a decoration for a party.

The Central Committee felt that it is necessary to take drastic steps. They decided to inform the Community that they are attending to this matter, since it seems that the community is worried and upset. Another suggestion was to write to both Dartmouth and Willams. Of course, the Central Committee will have to meet with these girls.

Another special meeting is called for 10:00, March 24, 1941 in Mrs. Garrett's office.

Ruth Miller and Helene Ferris had four Dartmouth boys in Jennings until 8 o'clock in the morning. This party was disturbing the quiet. The secretary stopped Helene, who was running through the house, and Helene placed Helen Keeler and Joan Stokes for the

Jennings House

Fay Mowery, Joan Stokes, and Helen Keeler were brought up before the Central Committee for the long party held in Jennings March 22, 1941. These girls told the following about the party.

Fay, Joan, and Helen with their dates had been in Williamstown. They returned to the college at five o'clock in the morning. After returning they went in the card room of Jennings until six o'clock. The girls admitted they were pretty noisy, but not terribly so. The reason they disturbed other people seemed to be that they were near the suites. They had six cans of beer, but there was no singing. Margie Michaelson was among the party and called the Central Committee to see if they wanted her to come to the meeting.

The Central Committee discussed the situation with these girls and told them that it not only gave Bennington a bad name, but the girls themselves. The responsibility which is given to them by the college was also stressed. Fay, Joan, and Helen admitted that they should have tried to quiet the party in their living room and that they should have been more careful about their own behavior. They seemed to feel the import of taking responsibility and said that their behavior of March 22, 1941, would never occur again.

Ruth Miller told the Central Committee about their party in Jennings, March 22, 1941. There were three boys and three girls who came in at three o'clook and remained until six o'clook. The other members of the party were: Elsa Woodbridge, Joan Cummings, and Helene Ferris. Ruth seemed confused about the facts of that night. However, she said that her party had gone to the Merry-Go-Round and returned at 5:45 and then left to get some breakfast.

The Central Committee impressed upon Ruth that the behavior she displayed March 22 would look bad both for her and for the college to outsiders. She realized that it would and admitted that she had known the few rules involved, but had not thought about them at the time. Ruth said that this had never happened before and never would again so far as she was concerned.

Hadene admitted that it didn't seem wrong to her then, but that now she knows better. She thought the older girls knew what they should do and so felt safe in following their example, however, she realizes where her responsibility begins and ends.

Elsa Woodbridge said that she was Ruth Miller's brother's date. The other boys were from Dartmouth. Joan and she were the only ones who didn't know their dates well. Elsa said that she tried to insinuate that the whole party should break up, but since it didn't she went to bed anyway. She had to be polite because of Ruth Miller. Elsa said no one was tight, nor had they been drinking. She was surprised to find the party in the living room when she got up the next morning to deliver papers.

Elsa said that she had tried to impress the younger students in her house about their responsibility, but that it was a long process. She feels that the older students should show the younger ones what to do.

Joan Cummings said that she hadn't tried to make the boys leave and had never tried. She thought perhaps if the watchman stuck his head in the door of the living room it might help her to remember to go to bed and send the boys home. Joan didn't feel that more rules should be made.

"Kip Humphreys and bypy friend came in at 18:50 A.M. and at 1:10 A.M. two State Troopers came in, and asked to see the two girls. I had them come up to the Policeman's booth and the

Troopers gave them quite a talking to."

"The story that the watchman told me is that Betty Haas let Kip Humphreys and her boy friend take her car. They were all at the Merry-Go-Round together, Kip Humphreys and her friend, Betty Haas and Nancy Dennis were there with two boys in another car. Kip Humphreys started home first, and when she and her friend came out of the Merry-Go-Round they let the air out of some of the tires, on the car that Betty Haas and Nancy Dennis were in. This made Betty Haas angry. When she got back to the College, and found that Kip Humphreys was not back, she came up to the Policeman's booth, said that her car was missing, and asked if she might call the police. So he let her. It looks as if Betty Haas did this to get even with Kip Humphreys for letting the air out of the tires."

This problem was discussed and the decision was that the offenses were lending cars and practical joking. The Committee was agreed that talking to these before the whole committee would not be as helpful as having Lucile Bloch speak to Betty Haas and Edith Stevens talk to Kip Humphreys.

The suggestion of the policeman about the keys in cars can not be used because there is a rule that members of the Community must leave their keys in their cars. The suggestion does not seem to solve the problem in anyway.
