## FROM THE COMMITTEE FOR THE ASSOCIATES - -

## The College

If Bennington were just one of several hundred institutions offering the usual type of college education it might not seem important to maintain its stability and effectiveness. But you who know Bennington are aware that our program is distinctive and that our service to the students entrusted to us is of far more than ordinary value. The girls themselves are an exceptional group and the same is true of their teachers. Moreover, ours is a college which has made and continues to make a valuable contribution in the area of educational experiment.

## Liberal Scholarship Policy

It has always been the policy of Bennington to have a liberal allotment for scholarships so that no fine girl should be kept from entering because of insufficient means. To insure adequate scholarship grants, however, it is necessary to have resources beyond those of current income derived from tuition. Funds must be raised annually for this purpose by contributions to the College.

#### Endowment

You perhaps do not realize that when Bennington was opened in 1932, it was impossible to raise a backlog of endowment such as most colleges have. Actually, Bennington's total endowment amounts to only about \$150,000. Under present circumstances, few people are able to donate the sums necessary for an endowment which would yield sizable annual income, But many can contribute annual sums equivalent to income on endowments.

## The Associates of Bennington College

The formation of the Associates was an attempt to create such an annual income, especially for scholarships, which will be fairly dependable. Anyone who joins the Associates and makes a contribution will receive a reminder at the end of the year; there is no pledge to repeat the contribution, but it is hoped that Associates will continue their help according to their abilities on an annual basis. People give according to their means and small donations are as welcome as the large.

# What Membership Means

Associates naturally become a part of the college "family". They are kept up-to-date about college developments and plans. In this way they become a body of informed supporters who help not only financially but by acting as ambassadors of good will. The aid which Associates give by disseminating accurate information about Bennington and its program is as valuable as their financial support.
